The father said those were the only times he could think of that would have possibly made a mark or bruise. The father advised there is a bad court battle going on and anything like this is going to be pushed until he is not able to see the child.

I contacted the RP and advised her of the statement from the father. I also let her know he said he was not going to respond because of a fear of his words being twisted and used against him.

I recommended to both the RP and Father get recorders and record every message, for documentation purposes.
