Summary: RP last heard from his wife at around 0100 hours when he got a text from her saying she and the children were staying with "Ariana" at "Ariana's" house. "Ariana" is the babysitter the RP's wife hired to care for their children. RP stated his wife is filing for divorce against him. RP's wife is not answering calls, and he did not know if that was because she just didn't want to talk to him or because her phone had a dead battery. RP stated he does not know where "Ariana" lives, and his wife and children have not yet returned home. RP stated he had full custody of the children and his wife was violating his custody. I asked the RP how he had full custody, and he stated he had full custody as the children's biological father. RP admitted no custody agreement or court order exists for the children's custody. I explained to the RP that he did not have full custody, he and his wife had equal rights to the children. I attempted to explain to him that he would have to file for custody of the children with the court, but the RP interrupted me repeatedly to argue that he had full custody and his wife could not take his children. I attempted to explain to the RP that, until a civil agreement was reached between him and his wife, the Sheriff's Office could not take sides in the matter. RP claimed I was refusing to help him find his family and became increasingly beligerent. RP asked if there was another law enforcement agency he could speak to, and was informed that because he lived outside the city limits of Sonora, the Sheriff's Office was the agency that would handle his complaint. RP then told me "I'm pretty sure the city I live in is Sonora" even though he confirmed he lives on Ivy Dr. I told the RP where the city limits ended and repeated that he would need to pursue custody issues through the civil court system. RP could not articulate any threat or danger to his wife or children, just that they were not at home and his wife (who is divorcing him) would not answer his call. RP was extremely angry and was adamant that I had no idea what I was talking about. RP told me there would be "a big problem" before hanging up with me. Cellular E911 Call:
