Resp was eating toast when I arrived, had taken all her prescribed medications and was able to answer all my questions. Resp did not meet criteria for 5150 and was not gravely disabled. I encouraged the resp to cooperate with APS when they check on her and to take advantage of the services offered by the county. Resp seemed willing to speak with APS after I spoke with her. .
